    the Financing Agreement.
  - Facility Funding Agreement specifically states overruns may be paid to last three funded projects:
     Ocean Air Elementary, Solana Pacific and Caramel Valley Middle School. Willdan to show Director where overruns facilities are referenced in Facility Funding Agreement.
  - Land Acquisition Fund for Del Mar allowable uses: Land, Architectural/Engineer costs, does not fund construction costs. In order to access fund, must be one of the allowable uses, possibility exists of remaining funds contributing to overrun fund.
  - Master Plan Letter is presented to the City each year determining which schools would be funded;
     School District's determine this and may be edited.
  - The creation of CFD by the MKS development is yet to be determined where the funds would be allocated.
  - Adgendize for fall meeting.






### NCW/JPA ADMINISTRATIVE EXPENSE BUDGET AMENDMENT

SUBJECT: Board to amend budget by increasing Outside Consulting costs by \$4,000.

**BACKGROUND:** The NCW JPA has historically reimbursed member school districts for that portion of their annual demographic studies that is inclusive of the Carmel Valley/North City West school population. For FY 2015-16, the requested reimbursements are approximately \$23,800 exceeding by \$4,000 the approved portion of the Outside Consulting budget of \$19,800 for these expenses. ### **ITEM 8C**

### **DEMOLITION OF UNUSABLE RELOCATABLE CLASSROOMS**

SUBJECT: Board approval of request to demolish unusable relocatable classrooms

**BACKGROUND:** Since 1990, the NCWSFFA has purchased and delivered relocatable classrooms ("relos") to each of the member school districts. Currently, Del Mar has twenty nine (29) relos, Solana Beach has seven (7) relos and San Dieguito has twenty (20) relos. The useful lives of these relos was estimated at twenty five years and many of these relos are now near the end of their useful life, are or will be in disrepair and no longer usable by some school districts.

San Dieguito has requested permission to demolish ten (10) twenty to twenty five year old relos at the Earl Warren Middle School that are now twenty years old or more and is seeking Board approval to conduct the demolition.

FISCAL IMPACT: None

**RECOMMENDED ACTION:** Approve demolition of unusable relocatable classrooms as requested by each school district.
