5. PUBLIC COMMENT

There were no comments from the public.

6. FINANCIAL REPORTS THROUGH SEPTEMBER 30, 2017

Mark Risco presented financial reports. There were no comments or discussion.

7. EXECUTIVE DIRECTORS REPORT

- FY 2016-17 audit completed. No adverse findings by auditor during annual audit.
- Final Audit Report will be presented at the March Regular Board Meeting.

8. ACTION ITEMS

- A. Bob Quaid explained to the Board how overrun allocations were calculated.
 - The allocation of overrun costs to the Authority for each school listed in the Facilities Funding
 Agreement was based on percentage of NCW students to total student population for each of the
 respective schools as projected in Facilities Financing Plan from 2001.
 - The resulting percentages were applied to school overrun costs to determine the cost overruns payments due to each member school district.
 - The calculation and overrun allocations were presented in an attachment to the agenda package for the Board to review and approve. Total overrun amounts payable to the member districts on completed school facilities were approximately \$20.9 million with \$12.5 million to Del Mar, \$5.3 million to Solana Beach and \$3.0 to San Dieguito, including an estimated \$1.8 future overrun for the Carmel Valley Middle School Expansion still under construction.
 - Approximately \$9.5 million in unencumbered funds are currently available for distribution at
 September 30, 2017 with allocations pursuant to the Facilities Funding Agreement of approximately
 \$4.1 million each to Del Mar and Solana Beach and \$1.2 million to San Dieguito.
 - The \$11.3 million balance of the overruns would be paid as additional special tax are levied each year
 and net revenues were received from the County. It was estimated full payout would take
 approximately 10 years as annual surplus revenue over expenditures are approximately \$1.1 million.
 - Chairperson Dill directed Willdan Financial Services to provide quarterly analysis of projected surplus funds for distribution for Board to review.
 - Moved by Director Rafner, seconded by Director Decker to approve calculations of the reimbursable facilities cost overruns to member school district at September 30, 2017 and distributions of \$9,529,076 in unencumbered funds.

- B. Motion by Director Rafner, seconded by Director Decker to approve allocation of Community Facilities District No. 3 Special Tax of \$2 million 52.53% to San Dieguito Union High School District and 47.47% to Del Mar Union School District and distribution of funds accordingly.
