John Addelman described the documentation submitted to the prior administrator. Cathy Birks provided an overview of the documentation Del Mar Union School District was required to provide evidencing eligible reimbursement from the overruns. There was further discussion about the budgeted amounts and terms of the Facilities Funding Agreement.

Chairperson Rafner gave direction (i) to request legal counsel review the Facilities Funding Agreement for a not-to-exceed amount of \$5,000 moved to table the item to the next Board meeting and (ii) review documentation from San Dieguito Union High School District evidencing the eligible reimbursement amount.
