A. Facilities Cost Overrun Payment to Member Districts

Doug Floyd: There are \$1.2 million funds available for cost overrun. Staff recommends \$1 million in total cost overruns. The overruns will reimburse, for the final time, eligible overrun costs for Carmel Valley Middle School in San Dieguito HSD, and remaining funds will go to Del Mar Union School District for Ocean Air reimbursement, approx. \$700,000.
